Outreach and Enrollment

- Currently Pulling from the waitlist and outreaching to parents for potential enrollments
 - 4 Waves of Outreach to 1,767 children over the past 2 months (588 last week)
 - Currently received 129 applications for service (from Waves 1 -3)
 - There are just over 700 children on the waitlist currently
- Have a very low response rate (around 11% for the first 3 waves of outreach responded with applications)
- Let Parents Know that we are Enrolling
 - Please inform parents that we are enrolling and encourage them to complete a waitlist application
 - For parents that are already on the waitlist, please remind them to gather/prepare all of their paperwork



Local Referring Partners

- Quality Rated Center can also become a Local Referring Partner
 - Must complete an agreement and an orientation
 - For parents in your center or on your waitlist, a referral may be submitted to us.
 - If you are not currently signed up, please email <u>ccslocalreferral@wfscapitalarea.com</u>
- Local Referring Partners is Priority 3
 - We must outreach priority 1 and 2 first and then priority 3
 - Please prescreen for potential eligibility
 - Reside in Travis County.
 - Have a child/children under the age of 13 or 19 if a child with disabilities that needs child care.
 - Working/Training/In School at the minimum of 25 hours a week for a single-parent home and 50 hours a week for a 2-parent home.
 - Be within income guidelines no greater than 85% of State Median Income

Provider Updates and Reminders

- <u>Updated DOSS</u> in the process of collected updated DOSSs from all providers
 - If you have not completed, please sign and send back. If you have not seen an updated DOSS in your inbox, please email <u>ccsproviderservices@wfscapitalarea.com</u>
- <u>Attendance</u> continue to submit attendance manually even if using the CCAA machine
 - There are no updates about how long we will be continuing manual attendance recording.
- <u>Keep us Informed</u>— please let us know if a child will not be returning, if a child does not attend 3 days in a row without parent contact, you are closing due to COVID, etc.
 - Please email <u>ccsproviderservices@wfscapitalarea.com</u> with any changes.
- <u>School Age</u> referrals for providers providing full day care when schools go to remote only
 - We are continuing to process any changes that have been received from parents or providers.
 - Will need documentation from the school district stating that they are moving to virtual only
- <u>Payment Review</u> with each payment, please review your payment record to ensure that all is correct (for example, school agers attending full time)
