Quinton Buckley with BakerRipley present:

- COVID Closures—if you have to close due to COVID, please be sure to let us know. Please send your license numbers, closure and anticipated reopening dates, and who is affected (whole school, certain classrooms, number of children).
- Reporting Absences—All providers are asked to report each time that a child has 5 consecutive absences. This is done online, link to report: https://wfscapitalareacom-xzivj.formstack.com/forms/providers-submit-excessive-absences
 - Please connect with parents and encourage regular attendance.
- Updated MOU and Provider Information Form—We are currently updating all provider agreements and sending you a Provider Information Form (PIF) based on your closure calendar, published rates, and facility information. Those will be sent via DocuSign for your review and signature.
- Updated Maximum Reimbursement Rates—Rate increase was effective October 1st. Please be sure to check your November 5th billing to ensure it is accurate. This is the first payment going out where all units should be at the higher reimbursement rate. Your new rates will be reflected on the new MOU/PIF that will be sent out. Even if you have not signed your MOU yet you will still be paid at the higher rate. If you notice any discrepancies please contact us.
- Childcare for Service Industry Recovery—TWC recently approved funding to provide 12 months
 of childcare for Service Industry Recovery (please see PowerPoint for details on eligibility

- Maria M—Are Austin Code employee's considered essential workers? Specifically, a Code Compliance Officer. Quinton said to send him details and we can figure it out.
- Patsy H—How long will care be extended for City of Austin Essential Workers? Quinton said one
 year of childcare will be provided and if funding is still available at the end of it we will hopefully
 be able to enroll and additional year.
- Colin S—Can currently authorized parents switch to SIR funding or apply for SIR when they come
 up for reauthorization? Quinton answered that it is a little tricky because SIR is only available for
 12 months and there is no continuity of care so at the end of it the care will end. They would
 lose their spot for CCDF if they did that. Anyone on the waitlist can apply for SIR funding though.
