 Nicole Robinson – Upcoming Program Rule Changes (Chapter 809): TWC has implemented several rule changes. Some rules are effective 10/3/22 and others will be implemented in the near future (Please refer to Power Point slides and/or video recording for specifics).

Logan DeCleene with Baker Ripley presents:

- Texas Rising Star Program As of 10/3/22 all Early Learning Programs contracted with Child Care Services must meet Texas Rising Star Entry Level Designation. Programs will work to become certified as at least a Texas Rising Star Two-Star program by September 30th, 2024. Many resources and supports are available to programs working toward TRS Certification. Including a TRS Mentor. As of this meeting, 100% of all Capital Area providers are eligible for TRS Entry Level Designation!
- Child Care for Essential Workers Currently enrolling for the City of Austin and CDBG to
 provide child care for children of Essential Workers (please see Power Point for details
 on eligibility requirements). True attendance will be collected and tracked, so if any
 children are enrolled at your centers with this funding you will be asked to submit
 attendance on a monthly basis. **NEW** Families living in Travis County (outside of the
 COA full purpose boundary) may now be eligible.
