Prosecutors in the famous Lizzie Borden murder trial introduced evidence that included powerful details. For example, Borden burned the dress she wore the day she allegedly killed her mother and father, and prosecutors argued that she did so because it was stained with blood. But the defense team—using for the most part the prosecution's own witnesses—shot down every attempt to pin the dastardly deed on Borden. In the end, she walked free.
